# Chair's Report – “Getting to the Next Level”



Many organizations grow in discernable stages. At certain levels they spend time and resources to create practices and policies that make their recent growth sustainable, which then sets the stage for future growth. Someday we'll get to the point that ballot access isn't even a question and we won't be surprised that our candidates win races. I want us to get to the next level of our development, but I alone do not get to decide what getting the Libertarian Party of Maryland to the next level means.

It could be one of our candidates getting 5% in a statewide race. It could be reaching 42,000 (1%) of the registered voters affiliating as Libertarians. It could be raising \$50,000 a year and employing paid part-time staff to do the kind of tasks that are hard to reliably perform effectively with volunteers. You and others, newcomers and veterans alike, may have different standards and goals for what it means for us to progress to the next level.

Over the long-run, many of the different goals people work towards in our party reinforce each other. A spontaneous order arises if you trust that the different choices people make in support of liberty aren't competing over a fixed pie, but expanding the scope and depth of our common interest. With different tactics in different areas of

politics, we can all help move us towards greater liberty, meeting different audiences and issue-agendas.

But no matter the goal chosen, if we don't have people willing to take action to implement those goals, we won't get to the next level. Politics is largely determined by those who show up, but because of our small numbers, we need our level of commitment to be greater than just showing up. Pick a task, any task, and step up your commitment to liberty. The greatest difficulty we face is that managing volunteers with other volunteers is very difficult to sustain, because it is incredibly time-consuming and often inconsistent. Very few of us have that amount of spare time.

One of the best ways for volunteers to get involved in action is by helping our candidates for public office. Campaigning with fewer dollars than our opposition means we need a ground game that relies upon volunteers. Sign waves, showing up to support candidates at public speaking events, distributing literature or door-to-door canvassing, distributing signs, working the polls (especially during the primaries), these are time-consuming but simple tasks that volunteers can help tremendously with. Pick a Libertarian campaign and help that candidate spread the message of liberty. We get our best chance with most voters to engage people who don't spend all their time thinking about politics. We expand our base by exposing more voters to different applications of liberty to issues they care about. They won't all become libertarians, but they can become Libertarian voters. That, in and of itself, will help us reach the next level.

The *Free? State Libertarian* is mailed to all Libertarian Party of Maryland members and paid subscribers. You may have received a gratis copy (mailing label says “Join the MD Libertarian Party”) because you are registered Libertarian, are a member of the National Libertarian Party, or requested information. We appreciate you acting to: join the MdLP with the page 9 form; join the Central Committee; become a newsletter subscriber only (send \$20 to above address); and/or register Libertarian (when we get 1% of the state registered, we can end collecting petition signatures).

## Memberships Explained!

For this issue, we are also printing and mailing newsletter copies to non-MdLP, but National LP members in the state. The various memberships are often confusing –

National LP: being a sustaining National LP member is great, but is separate from the *Maryland* party.

Maryland LP (MdLP): We are the *state organization* which publishes this newsletter, has meetings, events, provides outreach booths, etc. We are in your community and support Local Groups. Annual dues is \$20.

Maryland State Central Committee (CC): the CC is the legal entity approved by the Board of Elections. We provide the “Libertarian” party status for candidates on the ballot; our existence permits the LP Presidential nominee to run in Md. CC members must be MdLP members; must be registered Libertarian in Md.; and state their agreement with the non-aggression principle. They are the *voting* members of the state party and put state candidates on the ballot at meetings (we don’t have primary elections). There is no additional cost.

Local Groups: there are 14 geographical groups (constituted mostly by county, see page 9) that have meetings. Technically these fall under the auspices of the MdLP *Local Ad-Hoc Committee*. Local Group members may or may not be actual MdLP members; Local Group members are not MdLP members unless they specifically join and pay MdLP dues.

Registered Libertarians: any state resident who registers to vote may choose to be registered as a Libertarian. There is no requirement to belong to any of the above organizations, and there are no dues. As of January 31, 2022 the state count is 16,659.

**We are talking to you!** We really, really want you to *join the MdLP* (send in the page 9 form, or click the *Donate* link at the top of the webpage to join). Become a CC and/or Local Group member if so inclined. It would be great if you also join the National LP ([www.LP.org](http://www.LP.org)). We really, really want you to encourage others to *register Libertarian* ([VoterServices.Elections.Maryland.gov/OnlineVoterRegistration](http://VoterServices.Elections.Maryland.gov/OnlineVoterRegistration)). Those currently registered as *unaffiliated* are prime targets. When we get 1% of the state registered, we can stop collecting petition signatures every four years. Support our state candidates. Come to our upcoming convention and meet like-minded neighbors.

### Directions:

- From Baltimore: Go south on St Paul St/Light St; use the right two lanes to turn onto E Conway St (0.3 mi); use the left two lanes to turn onto I-395 S (0.7 mi); take the exit onto I-95 N toward New York (0.8 mi); take exit 54 to merge onto MD-2 S/S Hanover St, continue to follow MD-2 S (1.9 mi); slight left onto Frankfurst Ave (1.1 mi); continue onto Shell Rd (0.7 mi); turn right toward E Patapsco Ave (135 ft); turn right onto E Patapsco Ave (0.2 mi); turn left onto Pennington Ave (1.6 mi); continue straight onto MD-173 S (4.4 mi); turn left (66 ft); turn left; *Beefalo Bob's* will be on the right (59 ft).
- From the north: Take I-95 S to exit 64 and merge onto I-695 E toward Essex (2.7 mi); keep right at the fork to continue on I-695 S (8.4 mi); keep left to stay on I-695 S (toll road, 5.5 mi); take exit 1 toward Hawkins Pt Rd/ Pennington Ave/Ft Smallwood Rd (0.3 mi); turn left onto Quarantine Rd (0.2 mi); turn left onto Hawkins Point Rd (0.2 mi); continue onto MD-173 S/Fort Smallwood Rd (2.7 mi); turn left (66 ft); turn left; *Beefalo Bob's* will be on the right (59 ft).
- From Washington: Take MD-295 N/Baltimore-Washington Pkwy to I-695 E toward Glen Burnie; keep right at the fork to stay on I-695 E (4.2 mi); take exit 1 toward MD-173/Hawkins Pt Rd/Pennington Ave/Ft Smallwood Rd (0.4 mi); use the middle lane to turn right onto Quarantine Rd (354 ft); turn left at the first cross street onto Hawkins Point Rd (0.2 mi); continue onto MD-173 S/ Fort Smallwood Rd (2.7 mi); turn left (66 ft); turn left; *Beefalo Bob's* will be on the right (59 ft).

# Editor's Finale

The weekend of October 24/25, 1998 hosted the MdLP's annual Convention for that year, at the Glen Burnie *Holiday Inn*. Nancy Millionie organized the two-day event. Brian Wilson, a popular local libertarian radio talkshow host, gave a pessimistic dinner speech which was somewhat controversial. I remember the event partly because for no particular reason I took photographs with my ancient Pentax film SLR camera. Afterwards, Lorenzo and Susan Gaztañaga – who my recollection tells me were the then *Free State Libertarian* editors, but the actual editor might have been Norman Rule – phoned me. They had noticed I had taken pictures. I thought that perhaps they wanted them for the upcoming newsletter; but to my surprise they asked me to take over as the editor. Which I accepted.

The December 1998 *Free State Libertarian* (I added the “?” starting the next issue) was my first issue as editor. This current issue is my 64<sup>th</sup> and final one as your Editor. The largest was 24 pages (March 2003) – I used to receive more contributions than in recent years. Especially in the early years we mailed them to prospects as well as MdLP members; as many as 1000 copies, we bulk-mailed them. There were lots of folding, taping, addressing, etc. parties in my basement with the pool table serving a non-billiards function. The last number of years I've done most of the preparation myself, mailing with stamps to fewer than 200 members-only most of the time. I've gone through at least four different print companies by my memory over the timespan. All of these issues are archived on our website along with my predecessors' back through January 1992.

January 2002 was my favorite issue for an esoteric reason. I put a picture in of Minoru Yamasaki (an American-born son of immigrants), the World Trade Center architect posing with his model for that project. As an engineer I cherish *building* things. Destruction is easy, design and construction much harder. I was not going to print yet another picture of the smoking towers. I choose to celebrate *creation* instead. I was very disappointed that the printing company I used had that picture come out overly dark.

There is always a temptation to discontinue newsletters. Of course, they serve the primary purpose of advising members of upcoming events and reporting on recent events. People tend not to think, however, about another function of organizational newsletters: they provide the most accurate history of an organization. History is not something in the forefront of our minds as we are busy with day-to-day goings-on, but eventually *someone* becomes interested in researching the past – ergo a natural search for back newsletter issues.

People think that websites fill that historical need. My old MdLP website had a calendar of events that certainly showed *upcoming* events, but the listings never expired – so one could look back and find every past activity. I have everything there

from January 1998 through April 2014, when we retired Neil McIver's Linux Apache webserver and transitioned to Wordpress and new webmasters.

I used to have a very informal gallery of photos on the website which also could be used to identify past historical events. I listed every MdLP candidate going back years. Many think that social media platforms replace these functions. But if you peruse our Facebook site you will not find such historical information. And proprietary social media websites do not guarantee longevity anyway.

The current website calendar shows no past activities and the website lists no past candidates. I do understand that some are in favor of very clean “now” websites without significant back history – I personally opt for an air-it-out attitude with a detailed back story that exhibits a sense of openness.

All of these above comments are meant to encourage thought about how we will go forward with our newsletters such that we retain reliable historical records. As the decades-old third largest political party in the state of Maryland, we deserve proper recognition.

And please, please – support your new Editor with submissions!



At the November 11, 2000 Central Committee meeting, I was first elected to the Executive Board, and at the Executive Board meeting on that date I was elected Secretary. I have filled that role ever since, serving with seven Chairmen. As of the upcoming Convention I am retiring from all MdLP positions and will not run for Executive Board. I take pride in seeing that matters are handled in a professional manner and have enjoyed that aspect of the office. I will tell you my greatest joy as Secretary over all that time: going to the polls and seeing Libertarian candidates on the ballot. While I take no credit for it,


my signature on the Board of Elections nominating form is one of the two (along with the Chairman) which literally place those candidate names onto the polling machinery. I have signed every such form since 2001 and never did a tear fail to come to my eyes when I walked into the booth. I have already signed the forms for the candidates we nominated last October, so the next general election will be the last time I can enjoy that particular moment of glee.

Thank you all for your confidence throughout these years, and I wish the very best to my successors. Au Revoir de N3IC.

MdLP Bylaws have us use this method of voting for Chairman, Executive Board, and delegates to the national convention should there be more candidates than positions. Only paid-up Central Committee members may vote. Our convention is a busy time, so please pay any outstanding dues via the website well before that date. If you are not on the Central Committee and wish to join, please also handle that with the Secretary in advance as well. To do so, send an image from [voterservices.elections.maryland.gov/VoterSearch](http://voterservices.elections.maryland.gov/VoterSearch) showing you are currently registered Libertarian in Maryland, and certify agreement with the principle set forth in Article II (the non-aggression principle) in our constitution.

If necessary, at the convention ballots similar to the one above will be distributed with the Candidate Codes and Candidate Names populated. You must clearly print your name and *sign* the document (we do not use secret ballots) for it to count. You may choose from one to the number of candidates to vote for; put their *Candidate Codes* – in order – in the 1, 2, ... 13 spots as shown above. Duplications serve no purpose. The data from all of these ballots must be typed into a calculating program on-the-spot at the convention, so please take care to write very legibly to speed up the process. We will have several data entry people, but it is still time-consuming.

At the end of a ballot, it is possible (likely) that the election is not complete; in such cases, candidates may voluntarily withdraw. If none do, then the candidate with the fewest totals (more than one if identical tallies) will be withdrawn; NOTA is never withdrawn. The next ballot is computed and this process continues until completed. Consult our bylaws for a full description.

We need everyone's cooperation to get this done in a timely fashion!

## Dean Ahmad comments:

It is easy to vote in our ranked choice voting system: just rank all candidates you are willing to see elected in your order of preference. The method of counting votes is admittedly complex, but it is worth it because it avoids the *winner take all* of common methods of voting. It also avoids the tendency to elect the *least objectionable candidate* of some other alternative voting systems.



## Community Activities

On November 25, the *Baltimore Sun* printed **David Grigg's** letter “Gerrymandered districts embarrass the state.” He self-identifies as a Libertarian and says that the large number of independents and members of smaller, principled parties should not be ignored in the considerations, especially in the drawing of the boundaries. “What the voters of Maryland deserve is a congressional district plan that a majority of Marylanders will think is reasonable.”

**Your Secretary/Editor** continues to be blocked by the *Baltimore Sun*. They neither printed nor posted online this December 29 response “Marijuana, again. Really?” In total it stated: “I have one question regarding the Dec. 29 article ‘Feds criticized after Ravenell acquittals’: how many taxpayer dollars were spent

prosecuting a case in which all charges apparently stemmed from ‘trafficking freights of marijuana across the country?’ Is this how we want money extracted from the population upon threat of imprisonment utilized?”

The *Baltimore Sun* on January 15 printed an op-ed by **Jonathan Gress-Wright**, “A costly, unproven way to reduce fire deaths.” He takes issue with the “claim that a 2012 state law mandating sprinkler systems in new homes was responsible for the decline in fire deaths (along with the law mandating all smoke alarms be installed with 10-year sealed-in batteries).” He says that these issues are better resolved at the local level and that “we should be seriously considering repeal of any regulations that unnecessarily increase cost of housing.”
